



WAIVER AND RELEASE FORM

Every person or such person's parents or guardians (if the participant is not of the age of majority in Oman) MUST read, understand, and complete all this waiver and release in its entirety before participating in any sports/activities/events on any/all ABA campuses or ABA organized events held off-campus.

By signing below, I confirm that I am the individual below or am the legal guardian of the individual below if they are under the age of majority in Oman and that I have read and understood this Waiver and Release. I also understand that if I do not understand anything presented in this waiver, I will seek clarity before signing.

I understand that this Waiver and Release is made for the benefit of ABA Oman International School, and each of its directors, management, officers, employees, insurers, and volunteers (collectively, the 'school').

I understand that there are inherent risks ('Risks') associated with my participation in sports/activities/events on or attending ABA's facilities.

I am aware that the Risks include but are not limited to, the potential for serious personal injury, death, property damage, or illness (e.g., communicable diseases such as SARS, avian flu (H5N1), MRSA, influenza, and COVID-19). I understand the Risks may be relative to my own state of fitness and health (including physical, mental, and emotional), and to the awareness, care, and skill with which I conduct myself.

I freely accept and fully assume all responsibilities for all Risks and possibilities of personal injury, death, property damage, illness, or other loss resulting from my participation in the above-described sports/activities/events. I accept these risks and agree to the terms of this Waiver and Release, even if ABA is found to be negligent or in breach of any duty of care or any obligation to me in respect of my participation in the activities/events.

I and my heirs, next of kin, executor, administrators, and assigns (collectively my 'Legal Representatives'), agree:

To waive all claims that I have or may have in the future against ABA Oman International School;

To release and forever discharge ABA Oman International School to the fullest extent permitted by law from all liability for all personal injury, death, property damage, illness, or other loss resulting from my participation in sports/activities/events due to any cause, WHETHER ARISING FROM THE NEGLIGENCE OF ABA, BREACH OF ANY DUTY IMPOSED BY LAW, BREACH OF CONTRACT OR MISTAKE OR ERROR OF JUDGMENT OF ABA, OR OTHERWISE;

To release and forever discharge ABA from all liability for all personal injury, death, property damage, illness, or other loss resulting from an infection, disease, virus, bacterium or other microorganisms (whether asymptomatic or not).

To release and forever discharge ABA from all liability for all personal injury, death, property damage, illness, or other loss resulting from public health emergencies, pandemics, or epidemics, as declared as such by the World Health Organization or any governmental authority.

To be liable for and to hold harmless and indemnify ABA from all actions, proceedings, claims, damages, costs, demands including court costs and costs on a solicitor and client basis, and liabilities whatsoever nature or kind arising out of any way connected with my, or my guests' participation in the sports/activities/events.

I agree that this Waiver and Release and all terms contained within are governed by the laws of the Sultanate of Oman. I hereby irrevocably submit to the exclusive jurisdiction of the courts of the Sultanate of Oman. Any litigation in any way relating to the sports/activities/events or to the matters addressed in this Waiver and Release must be instituted in the Sultanate of Oman.

I confirm that I have had sufficient time to read and understand each term in this Waiver and Release in its entirety, that I have read this Waiver and Release in its entirety, that I fully understand its terms, understand that I have given up substantial rights by signing it and have agreed to the terms freely and voluntarily. I understand that this Waiver and Release is binding on myself and my Legal Representatives.
